- 3. Tenders/bidders are requested to visit the website www.guwahatibiotechpark.com regularly. Any changes/modifications in tender enquiry will be intimated by corrigendum through this website only.
- 4. The Bidder or his authorized representative may be present at the time of opening of bid on the specified date. In case of unscheduled holiday on the closing/opening day of bid, the next working day will be treated as scheduled prescribed day of closing/opening of bid, the time notified remaining the same.
- 5. Eligibility of the Bidder:
 - **a.** The bidder should be a publisher or their authorized dealer/supplier.
 - **b.** The bidder must provide the copies of the following with their bids:
 - Trade License
 - Copy of GST Registration.
 - Copy of PAN No/ TAN No.
 - Income Tax clearance certificate
 - Audited Balance Sheets/ Income Tax return certificate of last three fiscal years.
 - The bidder must have at least two years of experience for supply of similar type of items in any recognized Colleges, Universities, Technical Institutes or other organizations.
 - The bidders are required to submit a declaration on letter head stating that the Firm has not been black listed by any Institute/Department/organization.
- 6. The rate should be quoted both in figure & words must be to inclusive all.
- 7. Rates quoted should be on FOR Guwahati Biotech Park, on door delivery basis. Vague terms like "packing, forwarding, transportation extra" without mentioning the specific amount will not be accepted. Where there is no mention of packing, forwarding, freight, insurance charges, taxes etc. such offers may be considered as all charges are inclusive. 11. The books offered should be of the best/standard quality available unless, otherwise specified conforming strictly to the BOQ cited.

12. EARNEST MONEY DEPOSIT

- Refundable Bid Security of ₹30000.00 must be submitted along with the "Bid" by means of Demand Draft drawn in favour of 'Guwahati Biotech Park Incubation Center' and payable at Guwahati.
- The Bid Security is required to protect the GBP against the risk of Bidder's conduct which would warrant the forfeiture of Bid Security in the following events:
 - a. If the Bid is withdrawn during the validity period or any extension thereof duly agreed by the Bidder.
 - b. If the Bid is varied or modified in a manner not acceptable to GBP during the validity period or any extension of the validity duly agreed by the Bidder.
- 13. **PERIOD OF VALIDITY OF BID**: Bid shall be valid for acceptance for a period of 120 days from the date of opening as indicated in the "Invitation for Bid" and shall not be withdrawn on or after the opening of bids till the expiration of the validity period or any extension agreed thereof.

 No bid may be modified (or) withdrawn after the dead line for submission of bids.
- 14. **Income Tax/Sales Tax clearance:** The tender should be accompanied by up to date Income Tax/Sales Tax clearance certificate.
- 15. **Quantity of Books:** The approximate quantities of item proposed to be purchased as mentioned in the list are liable to be increased or decreased at the time of placement of purchase order.
- 16. **Special discount/rebate:** Special discount/rebate admissible to Institute of National importance may be specifically indicated in the quotation if offered.
- 17. **Refection of offer:** Tenders not conforming to the terms and conditions and procedure so out lined are liable to be rejected summarily.
- 18. **Special condition:** Special condition, if any, printed on the quotation sheets of the tenders or condition attached with the tender will not be applicable to the contract unless these are expressly accepted in writing by the **Chief Executive Officer**.
- 19. **Payment Term & Mode of Payment:** No part payment as well as advance payment will be made. Payment will be made within 30 days on completion of the full supply of goods at Guwahati Biotech Park, Technology complex, IIT Guwahati, through NEFT/RTGS. In case payment is required by DD, the draft commission will be deducted from bill amount.
- 20. **Quotation through Fax/ E-Mail/Telegram etc.** shall not be considered. No correspondence will be entertained on this matter.
- 21. **Conformity to Specifications:** Specifications are basic essence of the product. It must be ensured that the offers are strictly as per our BOQ.
- 22. **Evaluation:** The bids will be evaluated soon after opening of bids as per the eligibility criteria in this bid document and during such evaluations any clarification or query maybe raised by GBP in email or letter/fax etc. The bidder should co-ordinate and reply in writing against such queries at the earliest possible time facilitating the evaluation process. Such written queries & replies will be annexed with the bid and shall be treated as the part of the bid.

23. Termination for default:

Default is said to have occurred

- If the supplier fails to deliver any or all of the services within the time period(s) specified in the purchase order or any extension thereof granted by GBP.
- If the supplier fails to perform any other obligation(s) under the contract.

If the vendor, in either of the above circumstances, does not take remedial steps within a period of 15 days after receipt of default notice from CEO, Guwahati Biotech Park (or takes longer period in-spite of what GBP may authorize in writing), GBP may terminate the contract/purchase order in whole or in part.

24. If a firm accepts the order and fails to execute the order in full or part as per terms and conditions stipulated therein, it will be open to the Competent Authority to recover liquidated damaged from the firm at the rate of 1% per month or the part thereof, subject to a maximum of 5% of the value of the undelivered books. It will also be open to the Competent Authority, alternatively to arrange procurement of the required books from any source, at the risk and expense of the firm that has accepted the order and failed to execute the order according in stipulations agreed upon.

- 25. **Applicable Law:** The contract shall be governed by the laws and procedures established by Govt. of India and subject to exclusive jurisdiction of competent Court & forum in Guwahati, India only.
- 26. **Force Majeure:** The supplier shall not be liable for failure to perform its obligations under the contract in the event of Force Majeure. The events referred to as force majeure that may hinder performance obligation of either party are (i) acts of God (ii).regulations of Government of India. (iii).any kind of natural disaster like earthquake, flood, epidemic and (iv). Revolutions, strikes, war, lockouts, riots, sabotage etc.
- 27. Consideration of Tender: Guwahati Biotech Park's decision shall be final and binding and no claims/representations in this regard shall be entertained. The acceptance of the quotation will rest solely with the CEO, Guwahati Biotech Park, who in the interest of the organization reserves the right to himself to reject or partially accept any or all the quotations and to withdraw or cancel entire bid process without assigning any reasons whatsoever. Mere submission of bid by the bidder does not vest any right in them for being selected.
