- 2. The inspection of the old machine Toshiba E-Studio 207 will be available at Guwahati Biotech Park during the period of tender i.e. from 08.03.2019 to 21.03.2019 and can be done with prior permission from the Administrative Officer of Guwahati Biotech Park.
