Terms and Conditions

- 1. Quotations will have to be submitted in a Sealed Envelope and should reach the office of the Guwahati Biotech Park on or before 20.09.2021 at 1.00 pm and will be opened on the same day at 2.00 pm.
- 2. Rates quoted should be on Door Delivery Guwahati Biotech Park Basis as per the format in Annexure I.
- 3. Quoted rates should be inclusive of all taxes.
- 4. The selected Bidder shall supply, install and calibrate the batteries with 10 KVA Capacity UPS and remove the existing Batteries immediately on receipt of purchase order at Guwahati Biotech Park.
- 5. The bidder should carry an on-site comprehensive warranty/guarantee of the item for a period of minimum 24 months. It shall be the duty of the contractual firm to replace/repair any of the non-functional Batteries during the Warranty/Guarantee period. The Tenderer shall invariably state the period of Guarantee/Warranty of the item offered.
- 6. The installation and calibration of the new batteries shall be done by qualified technicians having prior experience in dealing with UPS. The selected tenderer shall be fully responsible for any loss, damage, expenses, if any, that may be caused to Guwahati Biotech Park due to any defective installation and calibration and such amounts shall be recovered from the contractor.
- 7. It is the responsibility of the bidder to take the 60 UPS batteries (under buy back) from Guwahati Biotech Park and no expenses will be borne by Guwahati Biotech Park.

- 8. Quoted rates must be valid for 45 days from the date of submission of the quotation.
- 9. Payment Terms: 100% payment shall be made within 2-3 weeks from the date of successful delivery and installation of the batteries.
