QUALIFYING CRITERIA FOR BIDDERS

- 1. Registration certificate from any Govt. / Semi Govt. Dept. / Autonomous Body in appropriate class and category.
- 2. Average Annual turnover certificate and Audited Balance sheet certified by authorized chartered accountant for maintenance or Construction of similar works of last three (3) consecutive years. i.e. 2018-19, 2019-20 & 2020-21. Average Annual turnover should not be less than Rs.15.00 Lakhs
- 3. Shall have experience in execution of "Annual Maintenance Contracts of Electrical works including HT/LT sub-station in Govt. Institutional building /Office building/Residential complex/ Industrial complex, or "Execution of electrical works in construction of building works including HT/LT sub-station completed satisfactorily having a value of electrical part of the work not less than Rs. 10.00 Lakhs against single work order or Rs. 7.00 Lakhs against two work order in any one year during last five years in any Govt./ semi Govt. departments / Govt. Autonomous body. These are to be supported by copies of work order, BOQ and completion certificates from clients

- 5. The contractor should have a local office at Guwahati. The office address along with a copy of address proof, e-mail Id, Phone no of the office to be submitted along with the tender. The name of the contact person and his mobile number also to be submitted.
- 6. Should have valid Electrical contractor's license.
- 7. All the bidders are required to pay a bid processing fee of Rs 500.00 (Five Hundred only) and Earnest Money Deposit (EMD) of Rs12000.00 (Rupees Twelve thousand only) through online in the procurement portal failing which bids will be considered non responsive. GUIDELINES FOR BIDDERS

- 1. For all clarifications regarding site conditions, items of works or any other related matters to the tender, concerned Engineer may be contacted during office hours on all working days. Addendum/Corrigendum, if any, will be published only on Website. GBP shall not be responsible for any delay /difficulties / inaccessibility of downloading facility for any reason whatsoever.
- 2. Bidders are requested to quote their prices on a firm & fixed basis for the entire period of the Contract. Bids of the firms received with prices quoted on variable basis shall be rejected without assigning any reasons and no communication in this regard shall be made.
- 3. Refund of Earnest Money Deposit: The EMD submitted by unsuccessful bidders shall be returned to them without any interest whatsoever, within 15 to 90 days after placement of order on successful bidder. The EMD submitted by successful bidders shall be returned to them after the successful bidder deposits the security money according to conditions stipulated in the bid document.
- 4. Late/delayed tenders received due to any reason whatsoever will not be accepted under any circumstances
- 5. The bidder shall visit the site and acquaint himself fully of the site and no claims whatsoever will be entertained on the plea of ignorance or difficulties involved in execution of work or carriage of materials
- 6. Bidders need not come at the time of Technical bid as well as financial bid opening at GBP. They can view the bid opening after logging in the e- procurement portal at their remote end. If bidders want to join bid opening in GBP, they have to come with bid acknowledgement slip that generated after successful completion of the bids.

7. SUBMISSIONS OF BIDS

The bidders must upload their bids online as per the detail instructions given in the website **www.assamtenders.gov.in.** The Bidders must ensure that they upload their Bids not later than the closing time and date specified for submission of Bids.

8. PERIOD OF VALIDITY OF BID

Bid shall be valid for acceptance for a period of 120 days (One Hundred Twenty days) from the date of opening as indicated in the "**Notice for inviting tender**" and shall not be withdrawn on or after the opening of bids till the expiration of the validity period or any extension agreed thereof.

9. DOCUMENTS COMPRISING THE BID

GENERAL CONDITIONS OF CONTRACT (GCC)

1. SIGNING OF THE CONTRACT

The successful bidder shall be required to execute a Service level agreement within 25 days from the date of issue of the Letter of Intent. In the event of failure on the part of the successful bidder to sign the agreement within the above-stipulated period, the earnest money deposit shall be forfeited and the acceptance of the tender shall be considered as cancelled Identity Card.

2. IDENTITY CARD

Identity Card to all the workers / laborers under contractor's seal and signature for a specified period as per the terms of the contract and instructing them to carry the same during their movement/ work inside the campus.

3. SAFETY MEASURES

Suitable safety measure including scaffolding should be provided for workmen for all works to be executed during the contract period. All works to be carried out in accordance with relevant Indian Standards and as per Indian Electricity rule as amended from time to time.

4. PERIOD OF SERVICE

The contract shall be for 12 months. However, the GBP reserves the right to extend the duration of contract for a maximum period of three years based on the satisfactory performance of the contractor with same terms and condition.

5. CONTRACTOR'S SCOPE OF WORK AND RESPONSIBILITIES

- a. The work will include operation & maintenance of electrical installation, such as Street light, Building light, ceiling fan, exhaust fan, power points electrical, fire alarm & network wirings, earthlings etc. available in the Guwahati Biotech campus, Amingaon, Kamrup, Assam
- b. All small fabrication works, electrical works required for installation/un installation scientific equipment.
- c. Operation and maintenance of 33 KV substation of 2x 800 KVA capacity. (2 Nos Transformer of 800KVA capacity) and RMU
- d. Operation and routine, preventive and breakdown maintenance of Main Panel, Distribution Boards, LDB s, PDBs in the buildings.
- e. Routine and preventive maintenance of electrical switch gear and drives, pertaining to water supply.
- f. Operation and routine, preventive and breakdown maintenance of 800 KVA DG sets-2 Nos with AMF.

- g. Operation and routine, preventive and breakdown maintenance of Lighting & Power Distribution Systems
- h. Operation and maintenance of Audio/video system
- i. For carrying out the above job the contractor has to make his own arrangements for tools, tackles and measuring equipment, safety and protective devices for carrying out the work.
- j. Providing all kinds of technician/labour and the expertise required to attend to the above work is included in the scope of work
- k. All works to be carried out in accordance with relevant Indian Standards and as per Indian Electricity rule as amended time to time
- I. As the work involved is quite specialized and continuous monitoring is required, absenteeism of the contractor's employees will not be tolerated. GBP will make penal deductions in the bills for the absenteeism and non-compliance of the work. The contractor will ensure proper supervision at all the time. In case of deficiency penalty will be imposed.
- m. All the breakdown calls should be attended immediately, in case frequency / work demands more manpower, contractor will arrange additional manpower so as not to disturb the activities of GBP. No extra cost will be payable for that.
- n. Contractor shall provide Uniforms, Shoes, safety and protection gear, Identity cards etc., to the staffs deployed, at no extra cost.
- Contractor will ensure consistency of work and work force, correct trouble shooting, good workmanship, follow all safety procedures and will make all necessary efforts to maintain healthy environments and reliable services.
- p. Any other piece of work not specifically mentioned above but essential for the normal operation & maintenance of the works are also covered in the scope of contract.
- q. Contractor shall never say 'NO' to any of the requirement of Guwahati Biotech Park, which is in the area of Operation and AMC's technical services, as found reasonable to be entrusted to the contractor by Guwahati Biotech Park authority.
- r. **Contractor** shall abide by all the necessary requirement of labour laws regulation while engaging staff in the work

s. **Detail of Minimum Manpower**

- 1. Electrician (ITI certificate holder Skilled) 1 No--(Daily Basis)
- 2. Sound & Video Display operator for Auditorium and conference Room Program-1 No (Need Basis)
- t. The contractor shall also ensure that there is no shortage of operating staff for operation and maintenance of the works. If deployed staff is absent due to personal problem with due information to the contractor in writing, the contractor has to arrange for suitable alternative for the day/period to avoid any type of interruption to the work. If he fails to

provide any alternative, he will be penalized double the rate of the prevailing rate of the particular worker and the amount will be deducted from next running bill of the contractor.

u. Minimum Qualification:

- **1. Electrician (Skilled):** a) ITI Electrician Passed desirable. b) Having good knowledge in operation & maintenance of electrical/ telephone/Air conditioner/ LAN connection with minimum 2 years' experience.
- 2. **Sound & Video Display operator:** Having good knowledge in operation and & maintenance of sound and video.

6. MAINTENANCE OF LOG SHEET

The contractor shall have to maintain proper log books as per the instruction of the controlling engineer for the work to make the record available for inspection by the GBP. Any lapse in the record will attract compensation from the contractor as deemed fit by GBP.

7. SCHEDULE OF LABOUR RATES

Minimum wage of the staff should not be less than minimum Wage as per the circular of Office of the Labour Commissioner, Government of Assam.

8. **PAYMENT:**

- a) The contractor shall submit bill for the Schedule of Items every month within the 1st week of following month.
- b) The bill shall be paid after satisfaction of the GBP authority in respect to services rendered by the contractor against respective Operation & AMC works

9. **SECURITY DEPOSIT:**

- a) A sum equivalent to 10% of the accepted value of the tender shall be deposited by the Contractor as security deposit with the GBP. This may be deposited in full amount of 10% of the accepted value of the tender within 15 days from the date of issue of Letter of Intent.
- b) No interest shall be payable by the GBP from sums deposited as security deposit.
- c) Security deposit will be released 60 days after successful completion of the contract.

10. PENALTY CLAUSES:

- 1. Absenteeism: The contractor is to maintain the minimum man power as mentioned in the tender. If the contractor does not engage additional manpower of same category in case of absent of any staff, penalty will be imposed at double the rate of wages or salary for the day he remains absent.
- 2. Non- Compliance of work: In the event of failure of the contractor to comply with the complaint, the GBP shall be at liberty to engage other agency and get the work done and expenditure so incurred shall be recovered from the payment due to the contractor. Noncompliance to any of the complaints and not done satisfactorily would be recorded and recurrence of such incidents may lead to cancellation of the work order.
- 3. Accidents: Any accident due to negligence on the part of the contractor in following of safety procedures is purely at the responsibility of Contractor. GBP is not responsible for any such accidents/damages/death. Safety of the deployed staff by the Contractor is the sole responsibility of the Contractor.

11. TERMINATION OF CONTRACT:

GBP may, without prejudice to any other remedy for breach of Contract, terminate the contract in whole or in parts, if

- i.The Contractor fails to provide service within the period (s) specified in the contract or any extension thereof granted by GBP.
- ii. The Contractor fails to perform any other obligation(s) under the contract.

12. APPLICABLE LAW AND JURISDICTION

All matters connected with this shall be governed by the Indian law both substantive and Procedural, for the time being in force and shall be subject to the exclusive jurisdiction of the Courts at Kamrup (Rural)

13. CONCILIATION / ARBITRATION

If any dispute (s) or difference (s) of any kind whatsoever arise between the Parties, the Parties hereto shall negotiate with a view to its amicable solution and settlement through a committee appointed by CEO, GBP
