A. SCOPE OF WORK

Landscaping and Gardening

- Site clearing and surface preparation.
- Layout of planting zones.
- Plantation of ornamental plants, flowers, shrubs, grass carpeting if required etc

- Application of fertilizers and soil conditioners as required
- Ensuring a clean and aesthetic layout with uniform planting.

2. Must submit proof of successfully completed work of similar nature in government/PSU/private/other institutions.
